## **ORDINANCE NO. 2025-221**

**An ordinance of the City of Gainesville, Florida, amending the Future Land Use Map of the Comprehensive Plan by changing the land use category of approximately 1.19 acres of property generally located at 620 NW 16th Avenue, as more specifically described in this ordinance, from Mixed-Use Office/Residential (MOR) to Urban Mixed-Use (UMU); providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an effective date.**

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City hereby publishes the following information:

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare): **Change the future land use designation of the subject property from MOR to UMU in order to serve the public purpose of providing more business options for a vacant building so that it can be occupied with a business that employs people and pays taxes.**
