## **ORDINANCE NO. 2025-573**

An ordinance of the City of Gainesville, Florida, adopting the City of Gainesville Engineering Design & Construction Manual 2025 Edition in accordance with Section 30-1.6 of the Land Development Code; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

The public purpose of this ordinance is to update the Engineering Design & Construction Manual (EDCM). The EDCM establishes engineering design standards and specifications for the construction of physical improvements in the City and serves the public health and safety through implementing responsible industry standards and practices. Regular updates ensure the most current and accepted standards are being implemented.

The range for estimated impact due to the update to 3.8.2 was determined based on several potential scenarios and historic average unit rates for construction. It should be noted that within the last eight years, the need to close a pipe gap has occurred twice.
