## **ORDINANCE NO. 2025-760**

**An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas by rezoning approximately 1.87 acres of property generally at 1124 SE 27th Street, as more specifically described in this ordinance, from Single-Family (SF) to Public Services and Operations (PS); providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an effective date.**

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City hereby publishes the following information:

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare): **Rezone the subject property from SF to PS in order to serve the public purpose of providing more land area for the Alachua County Sheriff's Office facility so that they can expand their operations using the subject property for that purpose.**
