AUTHORITY: In accordance with authority granted under City of Gainesville Resolution 2010-091050, Section 9, each owner of Mobile Home or Recreational Vehicle (RV) Park property shall be afforded the opportunity to demonstrate, in the manner described below, the vacancy rate in space occupancy within such property and receive a vacancy adjustment to the Fire Services Assessments imposed upon such property. Occupancy means a mobile home or RV is occupying the space, whether in use or not.
