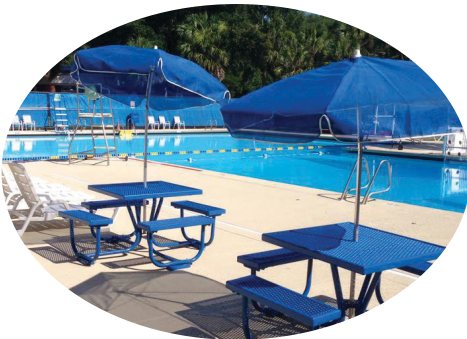

- In order to use the slide, diving boards or rock climbing wall, all children under the age of 18 must successfully complete a 25-yard swim test administered by the pool staff.
- Pool staff will be happy to administer this free test.

### **Participation waiver**

I am fully aware of the risk inherent and hereby release the City of Gainesville, any employees, any of its elected or appointed officials, or volunteers from any and all liability, claims, including attorney's fees and costs, and injury which may be sustained by me or my minor children on account of his/her participation in said programs or associated activities and events. It is understood that the City of Gainesville Parks, Recreation and Cultural Affairs Department reserves the right to dismiss any participant for just cause. The Parent/Guardian assumes all risks and will indemnify the City of Gainesville for all judgments and claims resulting from the actions or conduct arising out of the group's use of the premises and shall be solely responsible and answerable for damages and for all accidents or injuries to person(s) or property arising out of, or caused by acts or omissions, or the negligence of any participants. This indemnification does not cover personal injury or damage resulting from the sole negligence of the City, its agents or employees. For children less than 54" (4'6"), there must be one adult in the water for every 10 children. For children over 54" (4'6"), there must be one adult in the water for every 25 children. It is the responsibility of the group's leaders to supervise their children.
