- Local artists, municipal officials, and community health leaders will work together to create large-scale art projects to initiate sustainable change

- The project will run through Summer of 2024









- 1. Increased arts and cultural programs for youth

- 3. Improved mental health and well-being for youth in these programs
- 4. Increased multi-sector collaboration in our community

Gainesville Fire Rescue – Gun Violence by Zip Code January 1, 2021 – August 17, 2023






Summer 2024

Phase 1: Community Listening

- Establish and engage a Youth Steering Committee
- Phase 1 Call for Projects May through August 2023
 - Small-Scale Arts & Wellness Projects up to \$5,000
- Community Listening
 - What makes you feel safe in a community?
 - What arts and health resources exist in your community?
 - O What are healthy activities that you enjoy?
 - O What art do you want to see more of in Gainesville?
 - What kind of art and culture can make a positive impact in your community?







Phase 2

Grant Funding – Large Scale Projects

- Up to \$45,000 for projects focusing on multisector collaboration
- Based on Community
 Listening and youth
 engagement data
 learned through Phase 1

Phase 2 Funding Priorities

- Engaging youth impacted by gun violence or at high risk of gun violence
- Arts programs in the following categories: Visual Arts and Performance (dance, theater), and Music
- Cultural programs that are representative of minorities, diversity, and inclusive.
- Feelings of safety at the individual, relational/familial and community level.
- Increased arts cultural programming and well-being activities in under-resourced communities, leveraging existing health resources.
- Ongoing skill building programs for youth to increase socio-emotional functioning, conflict-resolution, and positive peer relationships.
- Leveraging other valued activities such as sports, nature, social activities, social media, and animals to incorporate arts, culture, and well-being.
- Artistic experiences for youth that are underrepresented in our community (e.g., photography, fashion, culinary, cosmetology/barbering)

Eligible Applicants

- Eligible entities include:
 - 501©3 Non-profit Organization (with a valid EIN from the IRS)
 - School or Educational Institution
 - Government Agency
 - Religious for Faith-Based Organization
 - For-Profit Business
- Individual persons are not eligible to apply.
- Entities must be currently qualified to conduct business in Florida, that are based in and/or provide programs and services to the City of Gainesville, FL. Applications from entities or organizations that do not have an ongoing footprint and engagement in Gainesville, FL will not be considered.
- All program activities and entities must serve City of Gainesville residents.
- Any special events must not conflict with the City's goals, core programs, and services.
- Events funded through this opportunity must be free and open to the public.
 - If programs have a fee to participate, there must be a reasonable plan to ensure youth impacted by or at high risk of being impacted by gun violence have a reasonable means and access to participate.
- Programs and events shall not have a predominantly religious or political purpose.
- Events and programs shall not promote the use of alcohol, tobacco products, illegal drugs or activities, gambling, or a sexually oriented business; or involve obscene or sexually explicit materials or content.

Funding Structure

- Funding through \$200,000 of ARPA dollars
- Projects can submit for up to \$45,000 of funding
- Reimbursement only (monthly or bi-monthly)
- Must include specific expenditures (i.e., receipts, invoices, staffing payments)

Allowable Expenditures


- Direct Program Costs (Expenses incurred as a direct result of program implementation.)
- Production costs
- Expendable materials
- Equipment and Venue rentals
- Marketing
- Organizational Salary support
- Professional Services (e.g., artistic, administrative, technical, mental health and well-being services, transportation, event security)
- Food for programs and events
- Other funding uses may be granted if deemed during the application review and approval process to be in the Program's spirit.

Phase 2 Grant Application Schedule

<u>Dates</u>	Key Actions

September 8 th	End of Question and Answer Period for Potential Applicants
October 2 nd at 5:00pm, EST	Grant applications closed. No late submissions are accepted.
October 3 rd – 23 rd	Grant Review and Initial Scoring Period
November 1st-3rd	Grant review and Q & A Scoring session. It is strongly suggested that applicants attend this meeting.
November 15 th	Final project selection and notification.
November 16 th – December 31 st	Project contracting and negotiation between awarded projects and City.
January 1st – August 15th	Funds available to awardees. Project implementation period.

Proposal Review

- Projects will be reviewed and scored by a panel
- Top projects will be offered an opportunity to attend a Q & A session to expand on their project
- Awarded projects will be notified and will initiate the contracting process
